COUNSELLING FOR ADMISSION TO POSTGRADUATE (MD/MS-AYURVEDA AND UNANI) COURSES UNDER 50% DELHI UNIVERSITY QUOTA FOR THE ACADEMIC YEAR 2024-25 :

It is notified for all concerned that in pursuance to the letter dated 28.10.2024 regarding reverting the vacant seats to the Delhi University and No. NCISM/Examinations/StateDME/2024 dated 12.11.2024 of NCISM, Ministry of AYUSH regarding Reduction of Minimum percentile criteria of NEET UG-2024 and AIAPGET -2024 for admission in Undergraduate (UG) & Post Graduate (PG) Courses of ASU for the A.Y 2024-25 and the decision of the Joint Admission Committee for PG (MD/MS – A & U) course the Counselling for admission to Postgraduate (MD/MS – Ayurveda and Unani) Course under 50% Delhi University Quota for the Academic Year 2024-25 the counselling schedule is being revised by the University of Delhi to fill the 12 vacant seats provided by the Ministry of AYUSH vide letter dated 28.10.2024 by reverting to Delhi University after the completion of Round – 02 of AACCC-PG Counselling 2024. As per the direction of the Ministry of AYUSH the candidates under 50% DUQ, who have not registered at AACCC-PG portal yet, but are willing to participate in DU-AYUSH counselling 2024, may also participate in the counselling for admission as per the following schedule :

1.	Online Fresh registration for such candidates of 50% DU Quota who have not registered themselves so far on the AACCC-PG Portal for admission to PG(MD/MS-Ayurveda) in the Academic Year 2024-25.	20.11.2024 (Wednesday) to 24.11.2024 (Sunday)
2.	Uploading of list of fresh registered applicants.	26.11.2024 (Tuesday)
3.	Publication of final lists as per merit of eligible candidates.*	28.11.2024 (Thursday)
4.	Publication of Result for 3 rd Round of Counselling (Category wise) as per merit on the basis of AIR.	29.11.2024 (Friday)
5.	Downloading of 'Provisional allotment letter' and reporting at allotted Institute/College for admission by the candidate as per seat offered on the basis of merit (AIR) and availability of seat in the respective category in the 3 rd Round of Counselling.**	30.11.2024 (Saturday) to 02.12.2024 (Monday)
